

Accessibility Statement

Poliform S.p.A. is committed to making its website accessible, in accordance with applicable accessibility laws. We are continually improving the user experience for everyone and applying the relevant accessibility standards.

This accessibility statement applies to the website www.poliform.it.

Conformance status

The **Web Content Accessibility Guidelines (WCAG)** defines requirements for designers and developers to improve accessibility for people with disabilities. It defines three levels of conformance: Level A, Level AA, and Level AAA.

www.poliform.it is partially conformant with WCAG 2.1 level AA. Partially conformant means that some parts of the content do not fully conform to the accessibility standard. The known non-conformances are listed below.

Limitations and alternatives

Despite our best efforts to ensure accessibility of Poliform, there may be some limitations. Below is a description of known limitations, and potential solutions. Please contact us if you observe an issue not listed below.

1. **Non-text Content (WCAG 1.1.1):**
 - Some non-text content presented to the user does not have a text alternative that adequately describes its content and function. In some cases, the provided alternative text is generic and not sufficiently descriptive. Additionally, some decorative images have not been marked as such.
2. **Info and Relationships (WCAG 1.3.1):**
 - In some cases, information, structure, and relationships conveyed through presentation cannot be programmatically determined or do not make sense without the styling information.
3. **Meaningful Sequence (WCAG 1.3.2):**
 - In some cases, the reading order of the content is incorrect, which may cause confusion when using assistive technologies.
4. **Use of Color (WCAG 1.4.1):**
 - In some cases, color has been used as the sole visual means of conveying information, indicating an action, prompting a response, or distinguishing a visual element.
5. **Contrast (Minimum) (WCAG 1.4.3):**
 - Some text and images of text do not have a sufficient contrast ratio, making it

difficult for users with low vision to read.

6. **Keyboard (WCAG 2.1.1):**

- Not all functionality of the content is operable through a keyboard interface without requiring specific timings for individual keystrokes.

7. **Link Purpose (In Context) (WCAG 2.4.4):**

- The purpose of some links cannot be easily determined from the link text alone or from the link text together with its programmatically determined link context.

8. **Headings and Labels (WCAG 2.4.6):**

- Some headings and labels are not sufficiently descriptive of topics or purposes.

9. **Name, Role, Value (WCAG 4.1.2):**

- For some user interface components, the name and role cannot be programmatically determined; states, properties, and values that can be set by the user cannot be programmatically set; and notification of changes to these items is not available to user agents, including assistive technologies.
